### Scope of Work

The British Council is seeking an accomplished Marketing Consultant to support day-to-day operations and contribute to active Cultural Engagement projects across Wider Europe and the European Union regions.

The Supplier will provide marketing and communications services:

Under the supervision of the Marketing Manager CE and in cooperation with Marketing CE team members, other British Council team members, and programme partners:

- Produce, maintain, and develop content for British Council websites, social media channels, and other communication channels.
- Manage and collaborate with British Council colleagues, associates, and external partners to contribute to the delivery of various marketing campaigns.
- Monitor and report on marketing KPIs for the projects as agreed with the Marketing Manager CE. Provide monthly, quarterly, and final reports as contributions to the overall British Council reports.
- Champion the deployment of the British Council brand architecture and programme projects' brand identity, monitor programme partners' compliance, and manage interventions to address and resolve reasons for non-compliance.

#### Location

Marketing Consultant will be based in Serbia, work could be done remotely in Serbia.

# Reporting

Marketing Consultant is expected to work closely with the British Council team. At the end of each month, the Marketing Consultant will submit a timesheet with the number of hours worked and a brief description of the activities or tasks performed.

The timesheet will be the basis for payment along with an invoice, which needs to be approved by the British Council. The timing of deliverables and frequency of reports will be agreed with Marketing Manager CE and rest of the team.

#### Requirements

- Degree-level or higher qualification, or equivalent experience in a specialist area relevant to the job.
- Experience in similar positions and working in international environments.
- Demonstrable experience in providing marketing and communication services.
- Good knowledge of digital and traditional channels of communication and media.
- Demonstrable experience in managing and mitigating internal and external communications risks and crises.
- Excellent written and oral communication skills; excellent organisational skills.
- Fluency in the use of IT, digital platforms, and social media.
- English language level C1 or above

#### **Application process**

- **Cover letter:** (two pages maximum) stating how they meet the qualifications and experience requirements, particularly experience in project development and management, and delivering training.

Note:

- Consultants will be offered a competitive hourly fee rate and will be paid for the days they actually work.
